

Museum Store Sunday Survey Sweepstakes Raffle Rules

Eligibility: Museum Store Sunday Raffle (“Sweepstakes”) open to any registered Museum Store Sunday participants who are 18 or older as of time entry. Employees of the Museum Store Association (“Sponsor”), its respective parents, subsidiaries, affiliates, advertising and promotion agencies and their family/household members (defined as parents, spouse, children, siblings, grandparents) are not eligible to enter. Void where prohibited, taxed, or restricted by law. All federal, state and/or local rules and regulations apply.

How to Enter: Enter by completing the Museum Store Sunday online survey. Limit one entrant per entry and one survey response per institution. Sponsor is not responsible for lost, late, or incomplete entries.

Drawing: Winner will be selected in a random drawing from all eligible entries on or about 12/20/17. The drawing will take place under the supervision of Sponsor. Participants agree to be bound by these rules and the decision of the Sponsor, whose decisions are final and binding in all matters relating to the Sweepstakes. Odds of winning depend on the total number of entries received. The winner(s) will be notified by e-mail or telephone on or about 12/22/17.

Prize: One free one-year membership in the Museum Store Association.

Eligibility/Release: If the winner cannot be contacted within 20 calendar days of first notification attempt, if prize or prize notification is returned as undeliverable, if winner rejects his/her prize or in the event of noncompliance with these Sweepstakes rules and requirements, such prize will be forfeited and an alternate winner will be selected from all remaining eligible entries. Upon prize forfeiture, no compensation will be given. [Limit one prize per person].

Conditions: All entries and requests become the property of Sponsor and will not be acknowledged or returned. Entry constitutes permission to use the winner’s name, picture, likeness and city and state of residence for purposes of trade, publicity or promotion for no additional compensation except where prohibited by law. By participating, entrants, winner agree to release and hold harmless Sponsor, and its respective parent companies, subsidiaries, affiliates, advertising and promotions agencies, partners, representatives, agents, successors, assigns, employees, officers and directors, from any and all liability, for loss, harm, damage, injury, cost or expense whatsoever including without limitation, property damage, personal injury and/or death which may occur in connection with participation in Sweepstakes, or possession, acceptance and/or use or misuse of prize or participation in any Sweepstakes-related activity and for any claims based on publicity rights, defamation or invasion of privacy. Sponsor is not responsible if Sweepstakes cannot take place or if prize cannot be awarded. Entrants who do not comply with these Official Rules, or attempt to interfere with this Sweepstakes in any way shall be disqualified. Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, extend or suspend this Sweepstakes should (in its sole discretion) non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Sweepstakes. In such case, Sponsor will select the winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Sponsor.
